In order to provide the service for control and administration of the handicap for Spanish sportspersons, under the RFEG, your name, surname, licence number and handicap details may be consulted over our web page in the conditions laid down.

In the case of professional championships, the data on the winners will be made public in our magazine and web page and will be made known to the Higher Sports Board in virtue of the Sports Act.

Similarly, in order to comply with what is laid down in Act 10/1990, dated 15th October, on Sport (art. 59.2: "all federated sportspersons participating in official competitions in the state will have to have compulsory insurance covering risks for health stemming from practising the corresponding form of sport") your data will be given to the Insurance Company with which this RFEG has arranged rendering of the health services. In the event of opposition to assignment of this data, the licence applied for cannot be issued.

Your data may be used for sending you the magazine of this RFEG, information about championships, events, news and other information connected with the purposes of this Federation and of the Territorial Federation to which you belong, as well as to promote the Visa Golf Card for federation members.

You are entitled to access, cancel, rectify or oppose processing of your data by writing to C/ Provisional del Arroyo del Fresno Dos, 5-28035 Madrid or through the Territorial Federation to which you belong through your licence.
